ASSUMPTION OF RISK AGREEMENT AND RELEASE

I (referred to as "Participant") desire to participate in the event described below ("Event") held on the property identified below ("Property") owned by High Street Baptist Church, or others listed below ("Sponsors"). I have been informed and understand that participation in events held on the Property may involve a risk of personal injury to myself. I understand that there is an inherent risk of injury in all sporting or athletic activities. Employee/Volunteer understands that in proceeding with the Production, Church will be relying upon the foregoing consent, permission, and indemnity.
